Inclusive Resilience in Somalia (IRiS) Activity

Somalia

2022-2027, USAID and FCDO

The IRiS Activity accelerates economic development for marginalized groups in Somalia by increasing individual, household, business, community, and system-wide resilience through rural and urban livelihood diversification and promoting economic market systems. The Activity strengthens and diversifies livelihoods for marginalized groups through climate resilient agriculture systems, integrates internally displaced persons into urban economies, promotes investments to diversify away from high climate risk agriculture, and supports private sector expansion. It also promotes the economic agency of marginalized groups.

Transition Initiative for Stabilization Saddex (TIS3)

Somalia

2022-2027, USAID

TIS3 assists Somali communities to establish the initial governance and security conditions necessary to address the long-term social, economic, and political causes of Somalia's instability by reducing the factors that enable violent extremist organizations to gain and maintain influence. To accomplish this goal, TIS3's work increases citizen engagement—particularly from marginalized populations—in political, economic, and security-related decision-making and increases the ability of communities to manage conflict peacefully.

Shejeh Salam

South Sudan

2020-2025, USAID

Shejeh Salam works with local actors in South Sudan to advocate for peace and advance communal dialogue within and among fractured communities. The project does this through trauma-informed activities that advance peacebuilding, strengthen civil society capacity, and support independent media while intentionally integrating gender, youth, and other socially marginalized communities into activities. Shejeh Salam's activities are currently focused on South Sudan's States of Western Bahr el Ghazal, Unity, Upper Nile, Jonglei, Eastern Equatoria, and Central Equatoria.

Afia WASH

South Sudan

The purpose of the Afia WASH Activity is to expand gender-transformative sustainable access to basic safe drinking water and basic sanitation coverage. The Activity also increases uptake of key hygiene behaviors to improve health and household resilience in accordance with USAID/South Sudan's Strategic Framework. Afia WASH is working with sub-national governments, communities, and private sector partners to ensure thoughtful sequencing and layering of activities, a robust network of partners, and strong stakeholder engagement.

Technical Assistance on Decentralization of Disaster Risk Management

Ethiopia

This Technical Assistance project supports the Federal and Regional Disaster Risk Management institutions to enhance the capacities of the local authorities to proactively and rapidly help communities cope with and be protected in the event of conflict and climate stress. This TA advises and supports the National Disaster Risk Management Commission in Ethiopia and regional institutions involved in disaster risk reduction on strategies, policies, and technical and operational issues related to the implementation of the disaster risk management strategy of the Ethiopian Government.

Toward Enduring Peace in Sudan (TEPS)

Sudan

USAID TEPS increases Sudanese capacity to address the causes and consequences of conflict, violence, and instability. The overarching goal of the project is to strengthen foundations for democratic and peaceful Sudanese development by promoting stability and establishing a basis for longer-term development. This project catalyzes stability in Sudan by encouraging greater engagement between communities and the government at state and local levels, while strengthening the capacity of Sudanese citizens to productively engage with elected officials.

Uganda Institutional and Systems Strengthening (ISS) Activity Uganda

2021-2026, USAID Feed the Future (FtF)

The USAID-funded FtF Uganda ISS Activity mitigates institutional governance, management, and market systems constraints to improve how system actors work together to achieve agriculture-led economic growth. The Activity applies a facilitative market systems approach to improve the agricultural policy framework and institutional systems and procedures, and spur target institutions to own the interventions that will sustainably overcome barriers. Uganda ISS also improves regulatory effectiveness through private-public sector dialogue to bring about desired reforms and encourage participation in policy implementation.

Cities and Infrastructure for Growth (CIG)

Uganda

2018-2023, FCDO

The FCDO CIG Uganda project provides demand-driven technical assistance to address constraints hindering urban development in the Jinja–Kampala–Entebbe corridor with particular emphasis on the Greater Kampala Metropolitan Area. CIG Uganda's vision is to develop a sustainable urban environment which supports Uganda's economic development and makes Kampala 'fit for purpose' as the engine of national prosperity and growth.

Liberia MCA Fiscal Agent Liberia

2016-2021, Millennium Challenge Corporation

To ensure transparency, accountability, and effective implementation of MCC-funded Compacts, MCAs normally hire an external Procurement Agent to assist in procurement of goods, works and services, and to assist in the administration of associated contracts. As the Procurement Agent in Liberia, we managed the \$256 million Compact to rehabilitate the Mt. Coffee Hydroelectric Plant, develop a training center for electricity technicians, facilitate creation of an independent energy sector regulator, and support an approach to nation-wide road maintenance.

Liberia Fish Town Road Construction

Liberia

This project is working on road development and transport in the Mano River Union region, including paving a road in Fish Town. Our services/oversight include: design and road safety review, tender evaluation and assistance with the works contract award process, construction supervision of the road upgrading work, and overseeing the defects liability period including monitoring final ancillary work and remedying of defects.

Rehabilitation of Freetown Water Supply

Sierra Leone

2017-2022. FCDO

This project improved access to safe water for approximately 600,000 people in Freetown, Sierra Leone. Our knowledge and expertise of engineering in low- and middle-income environments enabled us to integrate UK engineering expertise into the challenging urban environment in Freetown. Leading a consortium of firms, we worked to rehabilitate critical water supply infrastructure for the Guma Valley Dam. Our inputs included feasibility, design, construction, commissioning, and handover of the completed works and training of Guma Valley Water Company staff in operation and maintenance.

Nigeria Infrastructure Advisory Facility (UKNIAF)

Nigeria

2020-2023, FCDO

UKNIAF is the UK's flagship technical assistance initiative in Nigeria's infrastructure space. The project supports Nigerian government counterparts to catalyze sustainable infrastructure development at a national level and unlock the significant constraints currently in place, which disproportionately affect those in extreme poverty. We support the Road and Power components of UKNIAF, including institutional reform within the Federal Road Network via a set of advocacy measures and support to the National Mass Metering Programme to improve the liquidity of the power sector.

Conflict, Stability and Security Fund (CSSF)

West Africa

CSSF addressed conflict and fragility globally. DT Global, in a joint venture with Tetra Tech, provided monitoring, evaluation, and learning services for CSSF West Africa to help to build an evidence base to strengthen learning and to understand what works and why across project, portfolio, and thematic areas. Our work included third party monitoring for Mali MINUSMA, a scoping study in Nigeria, research on maritime security in the Gulf of Guinea, and a gendered conflict analysis of the Sahel region.

Technical Assistance to Support to Culture and Employment

This TA supports priority sectors in culture and tourism. It increases the efficiency of public institutions in their services to cultural industries that contribute to the country's economic growth and social cohesion. The priority sectors include: image (cinema and television), performing arts (music, theater, storytelling, and dance), crafts, and applied arts (design, fashion, and accessories).

Increased Access to Electricity and Renewable Energy Production (IAEREP) Project

The IAEREP Project supports the Government of Zambia to increase access to clean, reliable, and affordable energy and to guarantee production of renewable energy, with a focus on gender integration. The project helps public institutions revise, reinforce, and develop policies, as well as create institutional, legal, and regulatory frameworks for unlocking the potential of renewable energy and increasing its efficiency throughout the country.
