Our interventions help local communities and governments to achieve durable peace, ensure access to justice, and strengthen human rights protections. By providing the expertise and training to strengthen government institutions, reform systems, and support transparency and accountability, we build the consensus and capacity for lasting change.

Effective Governance

DT Global works with communities and governments at the national and sub-national levels to improve democratic governance. We provide technical assistance and training to strengthen governance systems, reform institutions, and identify and implement strategic reforms. Our dedicated specialists support public administration reform, results-based management, organizational development for institutions, and civil service reform—helping governments to become more responsive to their constituencies.

Rule of Law

DT Global supports rule of law initiatives that build the justice sector's capacity to provide equitable access to justice and enable governments and civil society to protect human rights. Our work combats public sector corruption, trains attorneys and law enforcement and security sector officials, builds correction services capacity, strengthens court administration, and enhances public accountability. We support legislative and advisory bodies, improve justice and penal systems, and promote freedom of expression. Our programs integrate the most vulnerable members of society—including women, children, people with disabilities, and minority groups—and work towards universal access to legal protection.

Government Reform

DT Global strengthens local governance, decentralization, administrative reform, and service delivery. We help governments design and implement participatory strategies for political, administrative, and fiscal decentralization, and assist in building the political will for authority transfer. Our work ranges from supporting national decentralization strategy roll-out to providing strategic communications support. Our programs streamline the administration of social protection systems, licensing, registrations, and civil registry services. By introducing one-stop shop e-government services and citizen service centers, we work with governments to enhance municipal service provision.

Civic Engagement

DT Global builds civil society capacity and encourages citizen participation in political processes. We increase transparency and accountability, give voice to citizen concerns, and respond to community service delivery needs. Our experts provide technical assistance to nascent and emerging organizations in grant implementation, financial management, gender mainstreaming, and monitoring and evaluation. We work with civic groups to implement programming that supports an active and engaged citizenry.

Public Financial Management

DT Global provides technical advisory services to reform regulatory systems, strengthen public administration, and modernize the financial sector by establishing and enforcing market-supporting institutions. Our experts provide an array of capacity building services to government institutions—ministries, treasury offices, tax and auditing departments, national statistics institutes, and regulation and cadastre offices—including institutional strengthening and training, administrative reform related to fiscal policy and debt management, financial system and capital markets strengthening, Public Expenditure and Financial Accountability assessments, and macroeconomic policy assessments. We also offer assistance in financial management processes and systems, procurement, budgeting, revenue collection, expenditure control, and auditing.

Elections

DT Global strengthens good governance and conflict prevention through independent monitoring and oversight of general elections. Our work supports free and fair elections and reduces the potential for fraud, manipulation, and intimidation that can undermine electoral processes and civic confidence in electoral institutions.
